FUNDING SOURCE: Colorado State law requires that each county provide Core Public Health Services (Public Health Act of 2008). The scope of Core Public Health Services is determined at the local level and is based upon community needs, priorities, funding, and capacity. The Routt County Board of County Commissioners acts as the Routt County Board of Health. A 5-year term contract from CDPHE provides a framework for Routt County to administer environmental health related consumer protection programs and immunization services provided by NWCH. Parties entered into the 5-year term master contract in July of 2017 (contract routing #18 FAA 00052). Annual contracts under the 5-year master contract provide a scope of work, funding amounts for the year, and deliverables to fulfill contract terms.
