#### **MOUNTAIN LEISURE SUBDIVISION**

Mr. Goldich described the location of the Mountain Leisure Subdivision, which is on the north side of Seedhouse Road. The northern boundary of the subdivision is the southern boundary of the Steamboat Lake Subdivision Filing 4. Mr. Goldich explained that when the subdivision was approved in the late 1980s, the County wanted to ensure there would be an access from Steamboat Lake Subdivision Filing 4 to Seedhouse Rd. via an easement through the Mountain Leisure Subdivision. The approval of the Mountain Leisure Subdivision included a condition stating that if the access connecting Steamboat Lake Subdivision Filing 4 to the Mountain Leisure Subdivision was not constructed within 20 years, the easement would no longer be required. An additional condition stated that the roads in Steamboat Lake Filing 4 had to be constructed to County standards prior to the easement being granted. Mr. Goldich said that the County has been holding the deed for the easement since Mountain Leisure Subdivision was approved in 1988. The developers of the subdivision are now asking to be released from the easement agreement since the 20-year timeframe has expired and the roads in Steamboat Lake Subdivision Filing 4 have not been constructed. Mr. Goldich said that the document presented for signature is a release of the agreement. Once recorded, the title for these lands would be cleared of the encumbrance of the potential easement.

Commissioner Corrigan asked if there is another access out of Steamboat Lake Filing 4. Mr. Goldich said that there is not. The subdivision has not been developed, and none of the roads have been constructed. He presented a site plan and indicated the location of the unconstructed access road from CR 129 to Steamboat Lake Filing 4 which crosses USFS land. The developers of Steamboat Lake Filing 4 did not obtain an easement for this access road and the County did not require proof of access. The USFS has since stated that it will not provide an easement for access to Steamboat Lake Filing 4 through its property. Commissioner Melton offered that because the agreement was for 20 years only, the County could not deny the application. She said it would be the responsibility of the property owners of Steamboat Lake Filing 4 to negotiate an access easement. Mr. Goldich added that the zoning of Steamboat Lake Filing 4 also requires connection to a central water and sewer system, which does not exist. The lots could be consolidated into 5-acre parcels, but could not be accessed without an easement.

In response to a question from Commissioner Corrigan, Mr. Goldich clarified that the application for release from the agreement did not require adjacent property owner notification. Commissioner Melton asked about the ownership of the lots in Steamboat Lake Filing 4. Mr. Goldich said that several lots in the southern portion of the subdivision are owned by a single landowner, but that he is not sure about the others. He clarified that the only requirement for granting the easement was the construction of subdivision roads.

#### **Public Comment**

Ms. Kendra Alfieri, a member of the homeowners' association board of the Steamboat Lake Subdivision Filing 4 stated that she had not been notified about the application. Commissioner Corrigan stated that this type of petition does not require adjacent landowner notification.

## MOTION

Commissioner Redmond moved to authorize the Chair's signature on the Release of Agreement for the Mountain Leisure Subdivision, as presented.

Commissioner Melton seconded; the motion carried 3-0.

#### ADOPTION OF UPDATED HIPAA PRIVACY POLICY

The Board of County Commissioners previously adopted a Statement of Policy of Routt County, Colorado, Concerning Privacy under the Health Insurance Portability and Accountability Act of 1996 and the Health Information Technology for Economic and Clinical Health Act (the "HIPAA Privacy Policy"). The Department of Human Services, who is designated as a "hybrid entity" under the HIPAA Privacy Policy, requested that Exhibit D-2, the Routt County Department of Human Services Records Request, be updated and replaced. Other non-substantive updates were also made including identification of County privacy officers named in the policy.

Commissioner Melton asked for a summary of what this policy protects. Mr. Knaus stated Human Services and Human Resources maintain protected health information. At this time Public Health does not require such a policy because of the services they do not offer. In the future this could change.

# MOTION

Commissioner Melton moved to approve Resolution No. 2021-067, a Resolution adopting an updated Routt County Privacy Policy under the Health Insurance Portability and Accountability Act of 1996 and the Health Information Technology for Economic and Clinical Health Act.

Commissioner Redmond seconded; the motion carried 3-0.

# CONSIDERATION TO APPROVE HIRING THE COMMUNICATIONS SPECIALIST II AT STEP 4

The Emergency Management Operations Director, David DeMorat, is requesting to hire Sarah Longchamps at Step 4 of the Communications Specialist II Pay Scale. Ms. Longchamps meets all of the education and work experience requirements to be hired at Step 4. She has a high school diploma, she has over 4 years of experience working at the Routt County Communications Center as a Dispatcher and over 4 years working at the Routt County Sheriff's Office as an Animal Control Deputy. Ms. Pearce recommends the approval of hiring Ms. Longchamps at Step 4 of the Communications Specialist II pay scale. The County Manager has reviewed this request and recommended it be placed on the agenda for your consideration for approval.

Mr. DeMorat talked about the difficulty in hiring and retaining new hires and is excited about hiring Ms. Longchamps from within the County. He also states that Ms. Longchamps is a trained and qualified D2 Dispatcher, although some of her qualifications have lapsed and will need to be renewed, she is a qualified dispatcher.

Commissioner Melton moved to approve the hire of the Communications Specialist II at Step 4 per recommendation of the County Manager.

# AMBULANCE PERMIT NUMBERS 54-21-21 AND 54-21-22 FOR NEW AMBULANCES OPERATED BY YAMPA FIRE PROTECTION DISTRICT AND STEAMBOAT SPRINGS FIRE RESCUE

Both ambulances have been inspected and meet the minimum equipment requirements for advanced life-support-equipped ambulance set forth by the Routt County Board of County Commissioners and the State of Colorado.
