I. DESCRIBE THE REQUEST OR ISSUE:	
<p>Discussion regarding the status of redrawing the Routt County Commissioner Districts using the 2020 Census data. The GIS Manager took direction from the August 16, 2021 worksession and redrew the three commissioner districts to balance the population between the districts. These changes were minor from the 2011 district boundaries.</p> <p>A second option has been drawn that balances both the population and the area covered by each district. This option is a big departure from the 2011 districts. The GIS Manager developed this option in case public feedback came in asking for a different option.</p> <p>This StoryMap (https://storymaps.arcgis.com/stories/fb567955cd0946d2af3075fd5dab9421) documents the two options. It includes population and area covered statistics for each option. There is also a feedback survey at the end of the StoryMap.</p> <p>We are looking for direction on which option to pursue further so that legal descriptions of each district can be written for the final Action Item/Resolution to come later in 2021.</p>
