EN RE: ITEMS OF NOTE FROM THE PREVIOUS DAY'S WORK SESSIONS

Commissioner Monger stated that the previous day the Board heard updates from the County Manager, County Attorney, Emergency Operations Director, Communications Center Manager, and the Sheriff.

EN RE: CONSENT AGENDA

Tami Eggers, 4-H Extension Agent was present.

The following items were presented for consideration, approval, and signing on the consent agenda:

- A. Approval of County Commissioners Minutes: Regular Meeting of January 23, 2018.
- B. Approval of the donation of six recycled 2012 HP Elitebook 8650 laptop computers to the Routt County 4-H Robotics Club.

MOTION

Commissioner Hermacinski moved to approve items A and B on the consent agenda and authorized the Chair to sign the related documents.

Under discussion, Ms. Eggers noted that 28 children attended the first robotics club meeting and she foresees this being a great success. The two leaders of the robotics club have been really dedicated so far and they have strong backgrounds in technology. Ms. Eggers added that they will be using the computers in conjunction with Legos Robotics Kits and the kids will code the kits on the computers from the Extension Office. There will be a robotics competition at the SOROCO High School then they will move on to the state competition in September.

Commissioner Monger seconded; the motion carried 2-0.

EN RE: PUBLIC COMMENT

Todd Hagenbuch, Tami Eggers, and Libby Christensen, Routt County CSU Extension Agents, were present.

Mr. Hagenbuch introduced Ms. Christensen, the new Routt County CSU Family Consumer Sciences Agent. The CSU Extension Office is thrilled to have Ms. Christensen onboard. She comes to Routt County most recently from the CSU Campus working in the Department of Agricultural and Economic Resources on food systems.

Ms. Christensen commented that she has her PhD in Geography from UC Davis where she worked on food systems as well with the National Farm to School Network and the Sacramento County Farmer Bureau. She also has experience working on agricultural land use issues with the elected officials in that area. She looks forward to working with the community as well as the elected officials in Routt County.

Commissioner Monger commented that Routt County has had a very strong 4-H and Extension program for the last 50 years and he looks forward to Ms. Christensen getting involved and becoming part of that success.

Mr. Hagenbuch added that the CSU Extension Office is tentatively planning an open house in the Extension Office in early April to show off the new kitchen and their newly reorganized office as well as introduce everyone to Ms. Christensen.

EN RE: STEAMBOAT SPRINGS FIRE PROTECTION DISTRICT

Doug Shaffer, Steamboat Springs Fire Protection District Fire Marshall, was present.

2015 INTERNATIONAL FIRE CODE

Mr. Shaffer stated this item is the request to approve a resolution confirming the adoption of the 2015 International Fire Code (IFC) with local amendments by Steamboat Springs Area Fire Protection District and authorizing its enforcement. The biggest change from the 2009 IFC to 2015 IFC is that the fee schedule was removed from the adoption to allow changing of the fees without needing to go back through the adoption process. The City Manager sets the fees based on the recommendation of the Fire District. The Fire District has adopted the code contingent of County approval.

Commissioner Hermacinski asked about the local amendment that removed a statement that restricted open burning. Mr. Shaffer replied that open burning is allowed in the City of Steamboat Springs and the amendment to that statement was to include language that indicates a permit is necessary for a recreational fire. The burn site is inspected for compliance and safety then a long term permit is typically issued.

MOTION

Commissioner Hermacinski moved to approve Resolution 2018-004, confirming the adoption of the 2015 International Fire Code (IFC) with local amendments by Steamboat Springs Area Fire Protection District and authorizing its enforcement.

Commissioner Hermacinski seconded; the motion carried 3-0.

No further business coming before the Board, same adjourned sine die.
