REGULAR MEETING
October 7, 2021**

Michael Olson, Chair, called the meeting of the Historic Preservation Board (HPB) to order. Rita Herold, Michelle Smoker, and Richard Slagle were also present. Karolynn Lestrud, Nancy Smith, and Trevor Gann were absent. Jennifer Parent prepared the minutes.

EN RE: ROLL CALL FOR QUORUM

EN RE: NEW BUSINESS

ELKHEAD COMMUNITY CENTER REQUEST

Ms. Parent informed the Board of Belle Zars recent submission of behalf of the Elkhead Community Center. Ms. Zars is requesting the Community Center be placed on the Routt County Register of Historic Properties. The application claims Statement of Significance A., *Its character, interest, or value as part of the development, heritage, or cultural characteristics of Routt County, the State of Colorado, or the United States.*

ROUNDTABLE:

The Board discussed the request. A typo, or discrepancy in the address of the Elkhead Community Center was found. It was found that 8105 RCR 56 is the correct address and the Applicant will be asked to modify that in the application.

The Board also discussed that the Community Center did meet the criteria for designation based on the applicant's choice of using Statement of Significance A., *Its character, interest, or value as part of the development, heritage, or cultural characteristics of Routt County, the State of Colorado, or the United States.* The Board found the Elkhead Community Center also met Statement of Significance D. *Its exemplification of the culture, economic, social, or historic heritage of Routt County.* They agreed to approve for Reason A and if the applicant wishes also Reason D.

MOTION

Ms. Herold moved to approve the application with the condition that the applicant clarifies the address, and at the applicant's discretion with the addition of Statement of Significance D.

Mr. Slagle seconded; the motion carried 4-0.

The date for the next Board Meeting was set for January 13, 2021. Current membership was discussed, as well as ideas for future meetings. Ms. Parent verified contact information for all members present.

No further business coming before the Board, same adjourned sine die.
