 The RC Purchasing Agent sent out RFP 744 D Unit 115 Motor Grader Replacement to 19 vendors and received 2 proposals:

<b>Vendor</b>	<b>Base Price</b>
Wagner	\$386,331.95
Honnen	\$392,763.07

The RC R&B Department has selected the proposal from Wagner as the best value for the County due to the proximity for service and price. We have selected the Bundle 3 option at \$12,200 for the Premier 60 month extended warranty which brought the total purchase price to \$398,531.85.
