V. BACKGROUND INFORMATION:

The Routt County Purchasing Agent sent out RFQ Patch 2022 to the two vendors in the County that have historically provided patch materials to the Road & Bridge Department. Oldcastle SW Group was the only quote received.

Patch Quantity	Unit	Unit Price	Extended Amount
2,500	Ton	\$87.00	\$217,500.00

In 2020, the price per ton was \$72.00. In 2021, the price per ton was \$75.15. United has stipulated in their 2022 quote that the price will hold throughout this year, but that as of January 1, 2023 we can anticipate a 10% increase per ton per calendar year moving forward.

The Road & Bridge department will take this into account during the budget process for 2023.
