**TAX LIEN SALE INFORMATION**

**INTEREST RATE:** This year's interest rate is 12% and accrued on a monthly basis.

**REGISTRATION:** Online registration for interested bidders must be completed at <https://routt.coloradotaxsale.com/>. Registration must include bank information. Payment for tax liens is by ACH ONLY. Real Auction will provide webinar training sessions in October to introduce investors to our online tax lien sale. The webinars will give step-by-step instructions about participating in the tax lien sale online. To register, please contact RealAuction at 1-877-361-7325.

**IRS REQUIREMENTS:** We are required by the Internal Revenue Service to issue 1099-INT forms to investors. To participate in our tax lien sale, you must complete a W-9 at the time of registration.

**WHO CAN PARTICIPATE?** 39-11-151(1)(b) C.R.S. " No tax lien shall be sold to an elected official, to a county employee, or to a member of the immediate family of such person or to the agent of any such county official or employee during the time the official or employee holds offices or is employed." Additionally, you must be of legal age (18) to participate in our tax lien sale.

**TAX LIEN CERTIFICATES OF SALE:** All certificates of sale are permanently retained by the Treasurer's Office. Successful bidders will receive a copy for safekeeping.

**ELEMENT OF RISK:** It is important to remember the element of risk involved in the purchase of tax liens. The purchase of tax sale liens of properties under the control of Federal Deposit Insurance Corporation (FDIC) and Resolution Trust Corporation (RTC) and those affected by the Drug Enforcement Administration (DEA) could possibly result in the loss of interest. Identifying any potential problems in this area is impossible for the Treasurer's Office. It is your responsibility, as an investor, to research and conduct your own investigation to reduce the possibility of loss to you.

Pursuant to 39-11-148(3) C.R.S., tax lien sale certificates are automatically canceled after fifteen years. It is your responsibility to track your investment.
